#### **Procedure:**

#### **Eligibility:**

1. Nominations are open to all citizens who have or are currently building a better Burke County.
2. Volunteers nominated must have provided service from January 2009 - December 2009.

#### **Judging:**

1. A panel of judges from United Way's current Board of Directors will make the decision.
2. Decisions of the judges shall be final.
3. Results of the judging will be announced at the United Way Celebration February 2010.
